



Mob Grazing Kit Loan Scheme Agreement

The Weald to Waves Mob Grazing Kit Loan Scheme is designed to support farmers and land managers to implement mob grazing on their land, by providing the necessary equipment for grazing an average sized field. **Through this scheme, participants can borrow kits containing all equipment needed to trial mob grazing and investigate its benefits for their livestock, land, and overall management.**

We do not charge for the temporary loan of these kits but expect that they should be treated carefully and used responsibly for the purpose defined above, with due regard to health and safety.

This agreement is entered into between **Knepp Wildland Foundation** (the "Lender", acting by its representative (the "Landscape Advisor")) and the individual or organisation countersigning this agreement (the "Borrower") regarding the temporary loan of a Mob Grazing Kit containing fencing and power supply equipment.

The Weald to Waves Mob Grazing Kit Loan Scheme is designed to encourage and farmers and land managers to trial mob grazing on their land. Mob grazing offers numerous benefits for livestock, land, biodiversity, and soil health.

This agreement is entered into for **a fixed period** (see *1. Loan Period*) between **the Lender and Borrower** regarding the temporary loan of a Mob Grazing Kit containing essential fencing and power supply equipment.

1. Loan Period

2. Mob Grazing Kit Contents and Return of Kits

The Borrower must ensure that the Mob Grazing Kit is returned to the Lender on or before the **End Date** specified above. The Borrower must ensure that the contents of the Mob Grazing Kit match the checklist below upon receipt of the box, and prior to returning. If the Borrower does not inform the Lender of any loss or damage, the Lender is entitled to assume that the kit is complete and in good condition.

Please note that ring insulators are considered consumables. These are not required to be returned and may be kept by the Borrower.

The Borrower confirms receipt of the Mob Grazing Kit in good condition and acknowledges responsibility for all listed items.

3. Gifting Mob Grazing Kits

Following the completion of the Loan Period, the Borrower may wish to continue to undertake mob grazing and may request the Lender to permanently retain the Mob Grazing Kit. The Lender is keen to encourage land managers to integrate mob grazing into their land management following the loan of a kit and may, in some cases, decide to permanently gift a kit to the Borrower. This decision is at the discretion of the Landscape Advisor who will prioritise cases where the continued implementation of mob grazing will offer significant environmental and agricultural benefits. The Borrower may wish to offer a financial donation to the Weald to Waves project (through the Knepp Wildland Foundation).

4. Use of Mob Grazing Kits

The Mob Grazing Kit is to be used **for the implementation of mob grazing on the Borrower's land**. The Borrower must ensure that the Mob Grazing Kit is used in a safe and responsible manner. The Borrower agrees to follow applicable laws, ethical guidelines, and any instructions provided by the Lender.

The Mob Grazing Kit must only be used on land owned or tenanted by the Borrower. The Borrower agrees to use the Mob Grazing Kit in the manner specified in the accompanying guidance and not to alter or misuse the equipment.

5. Care and Maintenance

Each Mob Grazing Kit is a valuable resource, with their approximate value being £2,300. The Borrower agrees to use the kit provided with care and return it in the same condition as received, allowing for normal wear and tear. The Borrower shall report any damage, loss, or malfunction to the Lender immediately.

6. Liability

The Borrower assumes full responsibility for the Mob Grazing Kit during the loan period and agrees to repair or replace any items lost or damaged beyond normal use. The Borrower shall follow any guidance provided by the Lender and agricultural best practice in deploying the Mob Grazing Kit and shall indemnify the Lender in respect of any loss, damage or claim relating to its use. The Mob Grazing Kit is for the use of the Borrower only and must not be loaned onwards.

7. Ownership

The Mob Grazing Kit remains property of the Lender (except through agreement under 3. *Gifting Mob Grazing Kits*).

8. Termination

The Lender reserves the right to terminate this agreement and request the return of the Mob Grazing Kit at any time, with reasonable notice.
